# REFUND & CANCELLATION POLICY

## 1. Policy Overview

This Refund & Cancellation Policy applies to all services offered under **Paranormal Investigator India**, which operates as an operational division of

## 2. Service Nature Disclaimer

Paranormal investigation services involve:

## 3. Cancellation Policy

### 3.1 Client-Initiated Cancellation

- This includes planning, documentation, scheduling, and preliminary analysis.

### 4.2 Eligible Refund Situations

Refunds may be considered only if:

- Services are cancelled **before initiation**
- Cancellation is due to company unavailability
- Legal restrictions prevent service execution **before initiation**

### 4.3 Non-Refundable Situations

No refunds shall be issued if:
